## Training subsidy and SBI verifier listing now open for application

Initiated by **Hong Kong Quality Assurance Agency (HKQAA)**, the HKQAA Sustainable Building Index (HKQAA SBI) is now inviting professional members of The Hong Kong Institution of Engineers to list as the "SBI Verifiers" who are the eligible persons to provide report verification service to the SBI buildings.

Launched in November 2011, the HKQAA SBI aims to drive long-term improvement in property management and thus enhance the quality and value of buildings. After consultations with stakeholders and on-site trial runs, the metrics of HKQAA SBI were fine-tuned and finalized in April.

In this seminar, we will provide the latest updates on the HKQAA SBI metrics, sharing of practical experience in compiling the HKQAA SBI report, as well as key issues regarding HKQAA SBI report verification. We will also explain details of the **subsidy programme for subscribing HKQAA SBI and continuing professional development funded by the Sustainable Development Fund (SDF)**.
